Failure to pay in a timely fashion may result in forfeiture of all starting times and assignment of tournament players to open time. **No later than fourteen days before the tournament date the golf course must be advised as to how many players are anticipated to play. The tournament chairman guarantees payment for that number.** The course will accommodate and charge for 10% of the players above the guarantee, however, **tournament chairman will be liable for the guaranteed number of players if he has no shows.** If the actual number of players on the tournament date is less than the number originally contracted for, the golf course has the option to move back starting times commensurate with the differential. Two copies of a reservation sheet listing players names and starting times should be provided to the golf course in advance of the tournament date. All tournament prices are subject to increase to the prevailing golf course rates at the time of the tournament, subject to sixty days notice. Food and beverage price quotations are subject to change with thirty days notice. All food-drink to be consumed must be purchased at the course. Westlake Golf Course reserves the right to cancel the tournament with ninety days notice. If playing conditions require cancellation by the course, the tournament will be rescheduled at customer convenience or all monies will be refunded. Frost may cause delay of starting times. Players unable to complete eighteen holes due to frost will be charged for nine holes only. Please call the golf course for advice if frost seems likely.
